Product: FME - Server of the ACT

Description:

The ACT (Land Registry and Topography Administration) has a centralised infrastructure of the FME Server solution from the company SAFE Software.

It is a tool for automating data format and data model transformations and allows the implementation of dedicated web services, with or without a geographic component.

Product:

LegiEurope

Description:

The "LegiEurope" application, developed by the Central legislative service (SCL) for the Ministry of Foreign Affairs (MAE) and all the other ministries, is based on the same architecture as the "legilux.public.lu" portal. It contains information about the transposition of European directives, from draft directives to the Court of Justice of the European Union.

This application facilitates the management and follow-up of the work of transposing European directives into national law, as well as the production of related reports and statistics for the Ministries.

The "LegiEurope" application is closely interconnected with the "Casemates" legislative database, and in particular also with the "LegiPro" Projects in procedure application and the controlled vocabulary.

Before the launch of "LegiEurope", the MAE had a FileMaker application and XLSs. The other ministries individually prepared their own tables showing the transposition of EU directives.

With the introduction of "LegiEurope", the government has a centralised IT tool for managing the transposition of directives. The MAE can inform the ministries as soon as "draft EU directives" are published. They can thus follow up EU drafts from the draft directive to possible referral to the Court of Justice of the European Union.

Product: Traités (Treaties)

Description:

The "Traités" (Treaties) application is an application developed by the SCL on behalf of the MAE. It contains information about bilateral and multilateral treaties in force for or signed by Luxembourg. The management of the "treaty data sheets" was previously done by the MAE, either on paper or in an Excel file. This application facilitates the management and monitoring of treaties, as well as the production of related reports and statistics. Treaty data sheets can be prepared instantly, making it much easier to prepare visits by Luxembourg Ministers abroad. Export to "Casemates" and Legilux will enable external users to follow the information on treaties in a new "Treaties" section (during/at the end of 2021). Interconnection with "LegiPro" will ensure even more efficient monitoring of treaties introduced into the legislative procedure.

The objective of LegiTp is to support government activities in the field of parliamentary work. The "parliamentary questions" module of LegiTp is positioned at the centre of the interactions between the three actors involved in the parliamentary questions process, namely: the Chamber of Deputies, the Central Legislation Service and the ministries, and makes the following possible:

- Ensuring and automating the application of the parliamentary questions procedure and facilitating actions and interactions
- Registering and transmitting questions
- · Preparing, registering, checking and transmitting answers
- · Request for extension
- Changes of responsibility
- Reminder process
- Formalism of communications with the Chamber of Deputies and Ministries, use of controlled vocabulary
- · Updating questions in case of a change of Government
- · Facilitating and optimising the work of Ministries around a question so as to provide a common answer (collaborative publication), validated by all
- Strengthening the respective roles of the different actors in the parliamentary questions process, in particular of the Ministry designated as the coordinator of the question
- Build a knowledge base of parliamentary questions and answers that is easily searchable
- Monitoring the parliamentary questions response process so as to facilitate its day-to-day management and extract instant statistics

The CIOTX application allows a user to initiate an electronic file exchange with third parties. Notification of a file dispatch or file request is sent by e-mail. The transfer of electronic files is done through a web application. The service allows sending files to a list of recipients, sending a request for transmission of electronic files, controlling the expiry of transfers, tracing operations and using functional accounts based on the access rights of the CTIE e-mail service.

CIBOR is an application which allows the registry offices to manage the registration of the metadata of these documents. The application enables this information to be managed centrally under the supervision of the Central Registry Office, an official mission of the CTIE.

eSign signature platform

Description:

eSign is the digital version of the classic signature pad. It works in a similar way.

- 1. A user (e.g. a secretary) prepares the electronic documents to be signed.
- 2. The user stamps the documents electronically and then prepares a folder in eSign containing the documents to be signed. He/she may attach information documents.
- 3. The file is passed on for signature to another user (e.g. the manager) at the click of a button.
- 4. The recipient of the file is notified by email. They open their file, consult the documents and then sign it electronically.
